



## EVALUATION RESULTS FOR PRE-QUALIFICATION PROVISION OF LEGAL SERVICES FOR WINDING UP OF INSTITUTION IN LIQUIDATION (IL). TENDER NO. KDIC/RFP/01/2024-2025.

## **COMPLIANCE WITH MANDATORY REQUIREMENT.**

All bidders were subjected to the mandatory requirements as provided in the prequalification document. Any bidder who failed on the mandatory requirement did not proceed to the technical evaluation stage.

**The Bidders listed below did not meet the Mandatory requirements as provided in the prequalification document and hence were disqualified and did not proceed to the next stage of evaluation.**

**B4.** (Macharia Mwangi and Njeru Advocates) did not submit Certificate of business incorporation/ registration and an up-to-date KRA tax compliance certificate

**B7.** MMC Asafo (Murui Mungai) did not submit Certificate of business incorporation/ registration and an up-to-date KRA tax compliance certificate

**B8.** (Abdulhakim and Company Advocates LLP) did not submit a valid practicing certificate for the Firm.

**B9.** (Kibungei and Company Advocates) did not submit a copy of the Law Firms valid tax Compliance Certificate

**B10.** (Chege Kibathi and Company Advocates) did not provide a copy of the Law Firms valid tax Compliance Certificate and Professional indemnity covers minimum Kshs 50,000,000.

**B12.** (Waweru Gatonye and Company) did not provide a copy of the Law Firms valid tax Compliance Certificate

**B13.** (CM Advocates LLP) did not provide a Professional indemnity covers minimum Kshs 50,000,000.

**B15.** (Wyne Associates) Law Firms Should have at least two (2) fulltime Partners.

**B16.** (Chege and Sang Company Advocates) did not provide a copy of the Law Firms valid tax Compliance Certificate and Professional indemnity covers minimum Kshs 50,000,000 and therefore fail to proceed to the technical stage of the evaluation.

The following bidders met all the mandatory requirements and hence proceeded to the Technical Evaluation stage.

#### **STAGE 2: DETAILED TECHNICAL EVALUATION.**

Bidders who qualified at the mandatory requirement stage proceeded to the Technical Evaluation Stage and were subjected to the Technical Evaluation criteria as provided in the Pre-qualification document.

The following Three (3) bidders scored below the set pass mark of **80%** as provided in the re-qualification document and therefore were disqualified;

- 1. **B1**(Mereka and Company Advocates scored **70%**,
- 2. **B5**. (Lok Law Chambers LLP scored **72%**,
- 3. **B17**. Njenga and Sang Company Advocates scored **47%**,

The following Five (5) bidders scored above the above the set pass mark of **80%** and hence qualified to be put on the KDIC approved suppliers/service providers list.

- 1. **B2**(Guandura Thuita Company Advocates) score **89%**,
- 2. **B3**(Komm Advocates) scored **100%**,
- 3. **B6**(Muthaura Mugambi Ayugi and Njonjo Advocates scored **100%**,
- 4. **B11** (Wanyaga and Njaramba Advocates scored **80%** and
- 5. **B14**(Triple OK Law Advocates LLP scored **93%**
